

GENERAL EXHIBITOR CONDITIONS FOR VENDORS & EXHIBITION AREA

HOCKENHEIMRING BADEN-WÜRTTEMBERG

BOOKING AND PAYMENT

- When booking a stand space, the trader acknowledges the General Exhibitor Conditions.
- The decision about the approval of an exhibitor and its exhibited goods lies solely with the organiser.
- Payment must be made before the respective event.

STAND RENTAL

- Upon the cancellation of a booking within 6 weeks before the beginning of the event, 50% of the stand rental will apply.
- If withdrawing within one week before the beginning of the event or if the booked space is not used, the full stand rental will be payable; likewise, there will be no entitlement to the reimbursement of advance payments.

STAND SPACES

- The spaces booked must measure a minimum size of 3 x 3 metres
 smaller spaces will only be granted by arrangement.
- Subletting of spaces is expressly forbidden.
- Advertisement of any kind is only permissible within the stand space (for outside, see DTM additional).
- The stand must be occupied by at least one person at all times.
- Disassembly may only be started after the official end of the event.
- The trader is obliged to return its space to its original condition after disassembly.

SALES APPROVAL

- The trader requires a 'Reisegewerbekarte' (itinerant trade card) to perform sales. If this is not available, approval must be requested from the town of Hockenheim. This can be carried out either via Hockenheim-Ring GmbH or by traders themselves. Costs must be borne by the traders themselves.
- The approval requested only applies for the stand spaces and items listed in the booking.
- The sale of food and drinks is only permitted with express written permission from Hockenheim-Ring GmbH. Violations of this rule will be punished by a contractual penalty of at least 3,000.00 EUR.

GOODS AND ITEMS

- Hockenheim-Ring GmbH only allows the sale of licenced goods and accepts no liability for the goods or services offered or sold by the exhibitor in any case.
- The trader is granted no exclusive sales rights for certain product groups.
- The sale of items with the "Hockenheimring" logo, the word "Hockenheimring" or the use of route silhouette in any context is only allowed with express written permission from Hockenheim-Ring GmbH.

ELECTRICITY AND WASTE

- Hockenheim-Ring GmbH will charge the exhibitor a flat electricity fee in accordance with the price list. Should consumption be proportionately exceeded, this may result in additional charges.
- Should a disproportionately large amount of waste be left in the stand space after the end of the event/disassembly, disposal may be charged for separately.

PARKING AUTHORISATION AND EXHIBITOR TICKETS

- Per stand, the exhibitor will receive one thoroughfare/parking permit and two exhibitor tickets (up to 25m²); additional thoroughfare/parking permits and exhibitor tickets required by the trader must be purchased for a fee in advance.
- Police-ordered blockage times for the protection of spectators will be noted on the thoroughfare/parking permits.
- Vehicles must be parked in the parking slots allocated to them.
- Illegally parked vehicles will be towed and charges applied.

1. LOSS AND DAMAGE

- Hockenheim-Ring GmbH accepts no liability for loss of or damage to exhibited goods or stand equipment. Furthermore, it does not accept liability for material damage and/or physical injury caused by the stand, the exhibited goods or the exhibition and/or sales activities.
- Each exhibitor must insure its own exhibited goods/stand equipment at its own expense.

DTM - additional

- The booking of a stand space for the DTM is subject to approval by the ITR. The ITR also reserves the right to ban or restrict excessive banners, flags etc. at individual stands.
- The trader will ensure that the goods it sponsors will place it in no competitive relationship at all with any of the DTM sponsors. It acknowledges the right of the ITR to object to the seller or the advertisement of products. Furthermore, it shall renounce the right to make any claims for damages against Hockenheim-Ring GmbH or the ITR, which make stand disassembly necessary due to a claim from the ITR, a main sponsor or for other reasons.

GENERAL

- In the event of violations of these conditions, Hockenheim-Ring GmbH reserves the right to dismissal.
- While located on the entire premises, the exhibitor/trader is subject to the domiciliary rights of Hockenheim-Ring GmbH.
- The place of performance is Hockenheim; the place of jurisdiction is Schwetzingen.
